

ADMISSION NOTICE

BA 3RD & 5TH SEMESTER

FOR APL CATEGORY STUDENTS

Admission of BA 3rd and 5th Semester will start from **08-10-2021** within **15 Days**

Admission Fee with Practical : Rs. 6,520/-

Admission Fee without Practical : Rs. 6,020/-

Students of APL Categories are directed to pay their Admission Fees at college counter using Debit/Credit Card. No. Cash will be entertained.

For BPL Category Students (Admission will start after declaration of Result of BA 1st and 3rd Semester Examinations)

(Fee Waiver Scheme for BPL Category students whose parental income is below Rs. 2 Lakh. As per Govt. O.M. No. AHE.354/2021/8) Dated the Dispur, 6th September, 2021) and who availed this scheme in 1st and 3rd Semester admission.

- Students who are willing to avail Fee Waiver Scheme under Pragyan Bharti are directed to come to college with all valid documents to get Fee Waiver Scheme for BA 3rd Semester and 5th Semester. If their documents are genuine and selected they must pay Rs. 1000/- as Admission Fees at College using **Debit/Credit Card**.
- 3rd Semester students (**Who had submitted Application for BPL Categories in their Previous BA 1st Semester Application Form**) can only be applied for BA 3rd Semester Fee Waiver Scheme and have to submit necessary documents.

Applicability for BPL Category Students

1. Category of students eligible under the FEE Waiver Scheme under Pragyan Bharti:

- Students whose parental annual income is less than Rs. 2.00 lakh from all sources will be eligible to avail this scheme.
- If either of the parent (mother or father) of the student is working in the State Govt./Central Govt./Semi Govt./State or Central Govt. Undertakings, such students shall not be eligible under this scheme.
- Scheme is only for regular students having minimum 75% of attendance in classes with no back paper in previous examinations.

2. Proof of Income/Documents required:

- An Income Certificate from the Local Revenue Circle Officer or the student or her parents may submit a Notary Affidavit in respect of her Annual income for availing the Fee Waiver Scheme which shall be accepted by the institution.
- The income Certificate so submitted by the candidate will have to be verified by competent Authority within one year and action as per law will be taken against anyone where submission of false Certificate is established.
- A declaration from the students that neither of the parents (father or mother) of the students is an employee of State Central Govt. Department or its undertaking. If such a declaration is found to be false, the admission shall be cancelled and fee shall be realized from such students. **(Download the Declaration Form from college website circular section)**

3. Duties and Responsibilities if Students availing the Scheme:

- The student has to nurse the sapling and while seeking admission into second year shall give photograph or the same tree that was planted during previous year. A Scrutiny Committee shall be constituted comprising teachers which will examine the photographs and will assess the genuineness of the Photographs and growth of the plant. Only on receipt of recommendation from the committee, the student can avail subsequent year fee waive. This will be effective from the session 2021 (applicable to those who benefited under the scheme during 2019-2020 and 2020-2021).
