The educational qualification and selection procedure will be as per Govt. Office memorandum No. AHE.407/2017/44 dated 08.11.2018

- Age: The age of the candidates should not be more than 38 years as on the 1st January 2020 with relaxation of 5 years for SC/ST/PWD and 3 years for OBC/MOBC candidates.
- Candidates must secure at least 55% marks (or an equivalent grade in a point scale whenever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University or an equivalent degree from an accredited foreign university.
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- Candidates who are or have been awarded a Ph.D. Degree in accordance with the UGC (Minimum Standard and Procedure for Award of Ph.D. Degree Regulation) 2009 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.

- NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.
- A relaxation of 5% may be provided at the graduate and master's level for SC/ST/Differently-abled (both physically and visually) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching position. The eligibility marks of 50% marks (or an equivalent grade in a point scale whenever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based only on the qualifying marks without including any grace mark.
- A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. holders who have obtained their Master's degree prior to 19th September 1991.
- The period of time taken by candidates to acquire M.Phil. Or Ph.D. Degree shall not be considered as teaching/research experience for appointment to the position.
- Candidate has to acquire qualifications as on the last date of submitting applications. Eligibility like M.Phil./Ph.D./Seminar Papers/Publications can be acquired and submitted on the date of interview but not beyond.
- In-service candidates must apply through proper channel with NOC obtained from the concerned authority.
- The candidate must have Permanent Residence Certificate (PRC) and must have proficiency in local language.
- Incomplete application will be rejected and no request will be entertained in this regard.



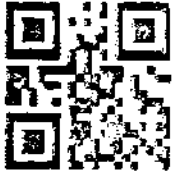

Heard Mr. A.D. Choudhury, learned counsel for the applicants. Also heard Mr. K. Gogoi, learned standing counsel, Higher Education Department and Mr. D. Das, learned standing counsel, UGC.

The present application has been filed for clarifying the order passed by this Court on 21.08.2019 in WP(C) No.5998/2019, by which this Court had directed, inter alia, that the

applicants/petitioners may be allowed to apply for the advertised posts of Assistant Professors in various colleges of Assam. However, their candidature and selection, if any, shall be subject to the result of the writ petition.

Learned counsel for the applicants submits that though the applicants have been allowed to apply for the posts, they have not been allowed to take part in the recruitment process, which is going on, because of the reason that the Director of Higher Education has not forwarded the copy this order to the respective colleges.

This Court fails to understand how the Principals of various colleges could avoid the order of this Court on the ground that the same has not been communicated to them by the Director when the same has been communicated by the applicants/petitioners to them.

Considering the submissions advanced by the learned counsel for the applicants, the applicants may file appropriate application before this Court as to why the concerned Principals did not comply with the direction of this Court so that appropriate orders can be passed in such proceeding.

A copy of this order may be furnished to the Director of Higher Education, Assam by the applicants for doing the needful.

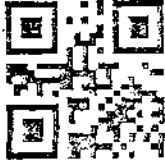

Heard Mr. A.D. Choudhury, learned counsel assisted by Mr. T. Chakraborty, learned counsel for the petitioners.

Issue notice, returnable within 3 (three) weeks.

Mr. S.C. Keyal, learned ASGI accepts notice on behalf of the respondent Nos. 1 & 2.

Mr. R. Majumder, learned Standing Counsel, Higher Education Department accepts notice on behalf of the respondent Nos. 3, 4 & 5.

Ms. T. Ghosh, learned Standing Counsel UGC accepts notice on behalf of the respondent No. 6.

All the petitioners claim that they are eligible for appointment to the posts of Assistant Professors as per the UGC Guidelines.

According to the petitioners, the State Government issued an Office Memorandum on 08.11.2018, by which they have laid down the selection procedure for appointment to the posts of Assistant Professor/ Librarian, which according to the petitioners, are not in conformity with the UGC guidelines. For example, though the UGC guidelines had not provided any specific minimum age of the applicant, under the Office Memorandum, the maximum age has been fixed at 38 years for General category with relaxation provided for other categories.

It has been also stated that by the aforesaid Office Memorandum, undue advantage is given to the candidates who had recently passed out their HSLC examination and most of the petitioners had completed their HSLC examination long before.

Further, as per the UGC norm, at least 25 marks are to be allotted to candidates who possess Ph.D. Degree. However, under the aforesaid Office Memorandum, only 9 marks have earmarked, thus, putting such candidates having Ph.D. Degree in a less advantageous position.

Other issues have been also raised in challenging the said Office Memorandum dated 08.11.2018.

This Court is of the view that the aforesaid issues can be examined after the respondents file their affidavit. However, in order to protect the interest of the petitioners, the petitioners may be allowed to apply for the posts of Assistant Professors as advertised by various Colleges in the State of Assam.

However, their candidature and selection, if any, shall be subject to the result of this petition.

In other words, the petitioners may be allowed to apply for the advertised posts of Assistant Professors in various Colleges of State of Assam. However, their candidature and selection, if any, shall be subject to the result of this petition.

List this matter again on 27.09.2019.
